(b) Social Media Policy We are wide open on it's use. The policy needs to reference the AO Code of Conduct. It was suggested that the policy needed to include a statement that AO has the right to use competition photos as part of its branding. As well, the Board felt that all Non-Compliance statements needed to be consistent throughout all AO policies. (c) Screening Policy It was suggested that AO needs a volunteer screening program. This would be and extension of where and how AO sources volunteers. It was suggested that the 10 Steps to screening process be made an appendix to this policy. (d) Anti-Doping Policy **Action:** Brian to insert links in the policy to: 1. Canadian Centre for Ethics in Sport (CCES) 2. World Anti-Doping (Wada) 3. World Anti-Doping for para-athletics.
