In order for the above Club Executive Officers to be insured as Directors of the Club and/or to carry the Club's vote at the Athletics Ontario Annual General Meeting, they must be registered individually as members of Athletics Ontario. **Application for Affiliation** must be made annually and the fee paid in order for the club to register its members and exercise its right to vote at the Annual General Meeting of Athletics Ontario. **Club members are not** members of Athletics Ontario until they submit a membership form and pay the appropriate membership fee. Membership expires each year on December 31 and is not renewed until the Club submits a new form and registration fee.

Athletes may not represent a club in any sanctioned competition unless that club is affiliated with Athletics Ontario. It is the Club's responsibility to ensure that athletes who enter or are entered in a 2023 competition are registered with Athletics Ontario. Clubs are also required to meet Athletics Ontario Membership Requirements prior to as per the Membership Policy found at: <http://athleticsontario.ca/policies-and-governance/>

For voting privileges at the Athletics Ontario Annual General Meeting an affiliated club must have a minimum of 5 registered Athletics Ontario members for the year. All Clubs should be in possession of the Athletics Ontario Policies and Procedures Manual. A manual may be obtained by contacting our office.
