

Application for Permission to Access the “Field of Play” to take photos and/or videos at track & field, cross country, Para, road and trail and race walk) events sanctioned by Athletics Ontario and Agreement concerning photography, including video, effective January 1st, 2024, through December 31st, 2024.

The undersigned (the “Photographer/Videographer”) is applying for permission to have access to the “Field of Play” for photographing athletes, coaches, officials, volunteers, spectators and other participants at track and field, cross country, Para, road and trail and race walk events sanctioned by Athletics Ontario (“AO”). In consideration for being granted access to the “Field of Play”, the Photographer/Videographer confirms and agrees to the following:

1. The Photographer understands that AO receives multiple requests from individuals who wish to take photographs, videos, or other images (“photographs”) and that access to the “Field of Play” must be limited for safety reasons and reasons related to the orderly running of an event.
2. AO grants permission in its sole discretion, and permission is further subject to the discretion of the event organizer.
3. Once confirmation has been given to the Photographer/Videographer by e-mail from AO that the Photographer/Videographer’s application has been accepted by AO, the Photographer/Videographer understands that they must request permission from the event organizer to access the “Field of Play” at that event. AO will notify the event organizer of the names of individuals whose application(s) has/have been accepted. It is within the discretion of the event organizer to disallow access to the “Field of Play”, even if the Photographer/Videographer’s application has been accepted by AO.
4. The Photographer/Videographer understands that among AO’s values is **Inclusivity: Leave no one out. As such, AO welcomes people of all abilities, ages, racial, ethnic, cultural, gender, and sexual identities**. We encourage an appropriate amount of diversity in photographs/videos taken to use the photographs. A lack of diversity may result in minimal, or no use of the photographs, images or videos provided.
5. The Photographer/Videographer confirms that they have read the **AO Code of Conduct** contained in the **AO Safe Sport Manual** posted on the [AO website](#) and agree to comply with the **AO Code of Conduct**. Without limiting this confirmation, the Photographer/Videographer confirms that they have read and agree to comply with the sections of the **AO Code of Conduct** headed “*Responsibilities - Participants*” and “*Social Media*”.
6. The Photographer/Videographer acknowledges that due to the nature of the sport and the activities of the athletes and other participants, photographs may capture images that could be considered embarrassing, disrespectful, or otherwise inappropriate, even when there is no intention on the part of the Photographer/Videographer to capture such an image. The Photographer/Videographer agrees to delete any such photographs/videos, not to share them in any way - and agrees to comply immediately with any request by AO to delete any such photographs/videos and not to share them in any way.
7. If AO believes, in its sole discretion, that the use by the Photographer/Videographer, whether by posting on social media or any other sharing, contravenes the **AO Code of Conduct**, AO may, in its sole discretion, revoke any permission given to the Photographer/Videographer to access the “Field of Play”. The Photographer/Videographer understands that such permission may be revoked with no prior notice and with no right to appeal such revocation.
8. The Photographer/Videographer will make available to AO, upon reasonable request by AO and at no charge, photographs and/or videos taken at events sanctioned by AO. This will be facilitated via the link provided by the Photographer, or upon request, via a link provided by AO. The Photographer/Videographer understands that AO will use such photographs only for non-commercial purposes unless AO has secured the specific permission of the Photographer/Videographer to use the photographs/videos for a commercial purpose. The Photographer will be credited for the photos and/or videos used.
